The Community Pantry Programs at Brave Space Alliance are based on a mutual aid framework where we aim to provide nourishing resources in a culturally competent and arming environment. Since its inception, the Community Pantry has grown into a pantry delivery program, a pantry at our home oce, and a network of 4 pantry partner sites across the city of Chicago that regularly serve 1500+ individuals each week. Our expansive network and programming allows us to reach communities beyond our oce in Hyde Park. We are hoping to continue the growth of our Community Pantry by redistributing capital and other resources through partnerships with local BIPOC growers and vendors across the city. Brave Space Alliance's food-based programs served over 300,000 individuals in 2020, across the City of Chicago.

Our Mutual Aid Program promote access, resources, justice and health within our communities by providing people with the tools and skills they need to create community oriented solutions for the barriers they face in their everyday lives. Our Mutual aid programs aimed at reducing or eliminating new HIV infections among Black and Brown transgender and gender-nonconforming people in Chicago, IL.
